1. INTRODUCTION

- 1.1. **Ryo Global Markets Limited** ("RYOEX," "we," "us," or "our") is a company incorporated under the laws of Saint Lucia with registration number **2023-00370**. Our registered office is located at **Top Floor**, **Rodney Court Building**, **Rodney Village**, **RodneyBay**, **Gros-Islet**, **Saint Lucia**.
- 1.2. This Risk Disclosure Notice (the "Notice") is provided by RYOEX to its Clients in order to help them understand the risks that exist in trading activities on financial markets. However, this notice cannot and does not disclose or explain all of the risks and other significant aspects involved in trading CFDs or other financial derivative products. The Client recognizes and accepts that there may be other risks which are not covered in this Notice.
- 1.3.
